## THREE (3) YEAR LIMITED WARRANTY

### What Does This Warranty Cover?

STACKABL provides a limited three-year warranty covering defects in material and workmanship. The warranty applies to the original consumer purchaser of our furniture from the date of original purchase. The warranty is not transferable.

### What Does This Warranty Not Cover?

This warranty applies under conditions of normal household use but expressly excludes:

- Damage caused by improper installation or assembly by the customer or a related third party
- Natural variations in materials including but not limited to color and finish
- Fading (furniture and lighting should not be placed in direct sunlight)
- Damage caused by exposure to weather or improper environment
- Normal wear and tear, including but not limited to any change in appearance or patina
- Cuts and scratches
- Defects that result from negligence, soiling, improper cleaning solutions or methods, improper storing, abuse, misuse, abnormal use, accident, or commercial use
- Costs related to installation or re-installation, or removal
- Costs for packing and shipping your product back to Stackabl for warranty evaluation

Please note that due to the nature of our work, each piece is different. Stackabl is not responsible for variations in materials, product size, dimensions, or specifications.

### How Can You Get Service?

Stackabl will, in its sole discretion, decide whether to repair, replace, or provide a substitute for any piece or part that Stackabl finds, in its sole discretion, to be defective in material or workmanship.

YOUR EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY OR OF ANY IMPLIED WARRANTY OR OF ANY OTHER OBLIGATION ARISING BY OPERATION OF LAW OR OTHERWISE SHALL BE LIMITED AS SPECIFIED HEREIN TO REPAIR OR REPLACEMENT, AT OUR SOLE OPTION. RESPONSIBILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES IS EXPRESSLY EXCLUDED.
